

6. Keeping, district, state and NITI with the issues, challenges for any necessary support.

- (a) Marks obtained in Matriculation examination attract 10% weightage
- (b) Marks obtained in Intermediate examination attract 10% weightage
- (c) Marks obtained in Graduation examination attract 40% weightage
- (d) Marks obtained in Post Graduation examination attract 40% weightage


Stage- 02 :- Top 100 Candidates are going to shortlisted for Interview according to criteria described in stage-01


Stage 02 will consist of Interview of 100 Marks.


Note :- Final selection will be on the basis of total marks obtained in stage-01 and stage- 02.


Reservation :- Reservation roster will be follow as according to GAD Bihar, Patna (Letter no 21485 dated 22.11.2023 of GAD).



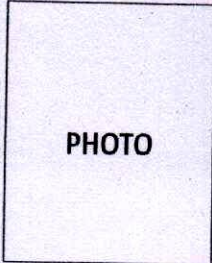
